Vaccinations. For the health and safety of our guests, all pets must be current on their vaccinations prior to check-in. Written proof of the vaccinations is required. We prefer vaccinations to be administered at least 7 days prior to check-in.

Required Dog Vaccinations: DTAPP (Distemper), Bordetella (required every 6 months if intranasal) , & Rabies.

Required Cat Vaccinations: FVRCP, Feline Leukemia & Rabies


Pet Health and Behavior

- If your pet is found to have fleas or ticks, you authorize us to remove them at your expense.
- We reserve the right to refuse any pet at check-in if it appears to be sick or injured, or its health or behavior jeopardizes the health or safety of any employees, clients, or other animals in our care.
- If your pet becomes sick or injured and requires veterinary care or other professional services during its stay, or in the unfortunate event that your pet passes away, we will attempt to contact you or your Agent. If we are unable to contact you or your Agent, we will use our own discretions to engage the services of a Veterinarian or other professional service at your expense.

Pet Safety

At Frenchie's, we have taken every possible precaution to make sure your pet is safe during their stay with us. You agree that, if requested, you have been given the opportunity to inspect the property and grounds, all fixtures to the property and grounds, all buildings and structures, all landscaping and vegetation, and all equipment being used by Frenchie's to certify its good standing. By signing this agreement, you certify that everything previously mentioned in this section is to your satisfaction and that you deem it safe for your pets stay. You also agree that in the event that any of the previously mentioned items in this section somehow contribute to, or cause an injury to your animal, that Frenchie's, its employees, owners or any interested party is not liable or responsible for that injury, or any costs that may arise from said injury including, but not limited to: vet bills, medication, surgeries, time lost from work etc.

Contact With Other Pets– While your pet is staying with us, he or she may come into contact with other pets.

- You acknowledge, and agree, that in the unlikely event your pet is injured by another pet, Frenchie’s and all of it’s employees, owners, and interested parties cannot be held responsible or liable for said injury.
- If your pet injures another pet during it’s stay, you will be solely responsible for any injury to either pet and any costs that may arise from said injuries.

Communicable Disease– All pets that stay at Frenchie’s are required to be vaccinated. However, it is still possible for a pet to become ill, even if vaccinated. This may not be due to any circumstances or conditions at Frenchie’s and you agree that Frenchie’s, its employees, owners and interested parties are not liable for any illness suffered by your pet during, or immediately following, its stay with us.

Promotional Usage– From time to time, we will take pictures or videos of your pet, or make a written description of your pet and their activities, while they are in our care. You agree that we may use these pictures, videos or written descriptions of your pet for promotional uses such as, but not limited to, flyers, websites, blogs, coupons, commercials, promotional videos, etc. without your further permission. You also acknowledge that if we use your pet, or its likeness, in any of these ways, you agree you are not subject to any compensation for its use. If you wish not to have your pet used in any of these ways, you may initial here to opt out of such usage: _____

Check-In and Check-Out– Check-in and check-out times are any time during our normal business hours. If you have not picked up your pet by the close of business, you will be charged for a full nights stay. Special arrangements may be made to pick up your pet after normal business hours for a fee of \$15. After hour pick-ups may not be any later than 8:00pm and such arrangements must be made at time of check-in.

Payment for Services– Payment for services must paid in full upon check-out. Payments accepted are: Cash, Check, Visa and MasterCard. (A \$25 fee will be assessed for all returned checks.)

By signing this agreement, you acknowledge that you have read this entire agreement, that you have had the opportunity to discuss its contents to your satisfaction, and that you agree to all of its terms and conditions. You also agree that this contract is binding for all of your pets in our care for this, and any subsequent stay.
